1. Create or search for your **BCIT Student ID Number**
2. Obtain a **Candidate Document Number (CDN)** from Transport Canada
3. Book a Transport Canada Seafarer's Medical for "Deck Service" with **Transport Canada-Approved Physician**.
NOTE: Medical Exam (typical cost is \$150 to \$250) will be reimbursed once student accepted into the program
4. Meet the English and Math entrance requirements:
 - Obtain copies of **HIGH SCHOOL** and/or **POST-SECONDARY TRANSCRIPTS**
 - Grades of 50% in each of English 12 and any Math 11 are required for entry
 - Digital copies of high school transcripts are available from the **Ministry of Education**
 - Assessment testing and/or upgrading available. **Sample Assessment Tests** available for review
5. Provide copy of **GOVERNMENT-ISSUED PHOTO ID** (i.e. BCID, Drivers' License, Passport, Status Card)
6. Provide copies of any **MARINE CERTIFICATIONS** currently held
